Will provide support for young people who need help with studying for their theory test, including covering the cost	Must only book a practical test when instructed by the programme coordinator which can be reimbursed. For more info see our Application Guidelines & FAQs	Must support and encourage their young person throughout their journey of learning to drive
Will provide ongoing support & advice to learners throughout their journey of learning to drive	Must provide your up-to-date availability for driving lessons when asked by the programme coordinator	Must support their young person with managing their expectations in relation to timeframes
Will liaise with the AA/BSM Driving School to find an instructor match & create an account for the learner	Must share you Pupil ID number with the programme coordinator upon request for the purpose of crediting your account	Must inform Live unlimited of any changes in circumstances including contact details, any safeguarding concerns as & when they arise

Will be responsible for crediting the learner's account regularly up to 46hrs. For more info see our Application Guidelines & FAQs	Must respond to communication from the project coordinator or instructor within a timely manner	Must inform Live Unlimited if their young person's practitioner changes
Will advise the learner with any issues that may arise on their journey of learning to drive	Must use the AA/BSM portal to manage lessons & liaise directly with your instructor regarding bookings	Must engage with Live Unlimited's project coordinator when contacted
Will raise any concerns from the learner/mentor with the AA/BSM Driving School to find a resolution	Must use the AA/BSM portal to cancel 72 hours before your driving lesson & notify your instructor. Failure to do so will result in the hours being lost	Must inform Live Unlimited about any additional needs, triggers or special circumstances we need to be aware of for us to be able to provide appropriate support to their young person
Will raise any concerns from the instructor with the learner and their mentor to find a resolution	Must inform the project coordinator of any changes to your circumstance including, address, contact details, etc	
May consider using alternative driving schools in certain circumstances. For more info see our Application Guidelines & FAQ	Must inform the programme coordinator of any issues that arise during your lessons or with instructor straight away
